1. BACKGROUND

1.1 The Health Committee has authority to oversee and undertake the Council's functions relating to the public health duty of the Council including health improvement, individual and community wellbeing and the reduction of health inequalities, and to assist the Director of Public Health in the exercise of the public health statutory duties. The Committee is also responsible for the Council's scrutiny of the health service.

2. MAIN ISSUES

- 2.1 When discussing its priorities and work programme for 2014/15, the Committee identified the following issues
 - Access to hospitals and other health services, particularly in relation to specialised services, and access from rural and some outlying urban parts of the County
 - The need for a more integrated and inter-agency approach to transport including making better use of resources, reducing gaps in provision, reducing road accidents, and encouraging walking and cycling.

The Committee identified that resolving these issues required close working between public health, the Health Committee, Economy and Environment and Highways and Community Infrastructure Committees.

At its meeting on 10th July 2014, the Committee therefore resolved to encourage the Economy and Environment Committee to appoint a health champion who would promote joined up working on transport issues.

The Committee has also set up a working group to support closer working between the Committees on transport issues.
