1. Background

1.1 It is a requirement to present an annual Risk report to Committee every year. This report focuses on the adults and public health Risks.

2. Main Issues

- 2.1 The Cambridgeshire County Council has a set of Risk Management procedures which sets out the key aspects of identifying, assessing and mitigating risks for the Council which includes:
 - Rating of risks are based upon their probability and their impact from a scale of 1-5 (5 being the highest level of concern)
 - Impact of risks are scored against five categories:
 - Legal & Regulatory
 - Financial
 - Service Provision
 - People & Safeguarding
 - Reputation
 - The Council tolerable level of risk is set at 16, where all risks above 16 will be escalated for further action / decision as required. This could be by way of accepting the risk rating at that time, applying additional mitigating actions and/or other actions to lower the risk level as appropriate
- 2.2 The main People Services Risk Register contains the main strategic risks from across the whole Directorate which includes, Education, Adults, Commissioning & Children's risks. This report contains only those relative to Adults and Commissioning or as a cross-cutting theme across People Services. In addition, Public Health also have their own risk register and their risks are also included in this report. Both risk registers can be found as Appendix 1 and Appendix 2.
- 2.3 The People Services Risk Register is regularly reviewed on a 6-weekly basis by People Services Senior Management and discussed bi-monthly at their Management Team meetings.
- 2.4 At the start of Covid-19 and as expected, all COVID risks were rated red as they met or went over the Council's tolerable level of risk, however, in these extreme circumstances this was expected. Over time, alongside the recovery phases and business as usual the risks were amended as government guidance changes and as mitigating actions were being applied, which in the main brought the risks down to a much more tolerable level.
- 2.5 The key areas of risk for Adults & People Services include:
 - Financial pressure for People Services, including the continual cost of living increases for clients, staff and providers
 - Provider sustainability is currently unstable due to lack of staff, cost of living increases and affordability to continue
 - Increase in demand for services as Winter sets in leading to longer waiting lists
 - Recruitment & retention of staff, including skilled, unskilled and qualified staff in frontline service teams both internally and within providers
 - The affect and implementation of the national Adults Social Care reforms

- 2.6 Key areas of risk for Public Health services include:
 - System workforce capacity
 - Inflationary pressure and/or grant reduction, leading to the real-terms reduction of the Public Health Grant.
- 2.7 For reference, the Public Health risk register details risks that have been recently closed, including:
 - Internal Workforce capacity.
 - Retention and recruitment.
