Aims and Objectives of Service / Document / Function					

To support the delivery of the requirements of the Act, the Council has developed a policy framework that will:

- provide clear direction to staff who are implementing the provisions of the Act and transparency for service users, carers, the general public and partner organisations.
- support the most efficient and effective use of the Council's resources
- underpin the new model of social work/ social care (Transforming Lives)

# What is changing?

Clear direction for stakeholders will be provided in the policy framework regarding the following changes:

## • Market shaping and provider failure

A set of principles underpinning the council's commissioning and market shaping activity will be outlined. This will support the Council to ensure that the local care market is shaped to meet the care and support needs of residents. The policy framework will also provide clear direction on how, and under what circumstances, the Council should intervene if providers are found by the Care Quality Commission to be at risk of failing.

# • Financial assessments and charges

The overarching principle that people should only pay what they can reasonably pay towards their care costs remains as it was. However, in line with national Care Act guidance, a new administration charge will be introduced for those who have been financially assessed as being able to pay 100% of their care costs that will be levied to cover the costs of arranging care for those who receive care in their own home. For those who contribute to care costs, charges will now apply from the start of a service, rather than from the date that the financial assessment is undertaken.

## • Deferred payments

Although the Council has administered a deferred payment scheme for a number of years, from the 1<sup>st</sup> April 2015 it will be a mandatory requirement to do so, supported by a new legal framework. The Care Act enables local authorities to operate these schemes on a cost-neutral basis (the Council pays the costs of care and recovers the money, plus interest, at a later date) which is a change to the current system.

## • Support planning

The provision of care and support planning becomes a duty for the Local Authority and users will have a legal entitlement to personal budgets. Currently this is only considered as best practice. The option of Direct Payments is embedded within the new legal framework. The policy emphasises that the Council has a duty to meet needs rather than provide specific services and so will develop and review flexible support plans for each person that are tailored to circumstances and needs and referencing latest best practice and technology. The policy statement clarifies how the Council will ensure that resources are used in the most efficient and effective way possible.
