Proposal being assessed: Intelligent Transport Systems maintenance procurement 2024

#### Business plan proposal number:

**Key service delivery objectives and outcomes:**Intelligent Transport Systems (ITS) describe technologies to assist, inform and control users of our highway network. These systems include signal-controlled junctions, pedestrian crossings and vehicle activated speed signs. As a local highway authority we have a 'Duty of Care' under Section 41 of the Highways Act 1980 to maintain our Intelligent Transport System asset to protect the safety of the public. There is also a need to have a supplier in place to provide and install new ITS equipment for site refurbishments or where new facilities are required. Currently this service is delivered to the authority via a jointly procured contract with 4 neighboring authorities.

What is the proposal: Cambridgeshire County Council is lead authority on the current consortium contract which started in September 2016. This successful contract was extended in 2021 and expires in September 2024, with no further option to extended. Working again with our partner authorities we have agreed to jointly procure going forward, with Luton Borough Council taking on the lead role. This procurement will provide a supplier to install equipment and provide maintenance on our existing assets. Although Luton are leading, Cambridgeshire have been involved at all levels of the process.

What information did you use to assess who would be affected by this proposal?: The public highway is by nature used by all in our communities, including anyone within any protected characteristics group. This procurement will deliver a supply partner to maintain and install new equipment. The way in which our communities use and interact with the asset is not affected by this proposal.
