1. ELECTION OF CHAIR

It was resolved to elect Councillor R Brown as Chair of the Joint Committee for the coming year.

2. ELECTION OF VICE-CHAIR

It was resolved to elect Councillor R Middleton as Vice-Chair of the Joint Committee for the coming year.

3. MINUTES – 25th FEBRUARY 2016
