#### 1. BACKGROUND

- 1.1 The Finance & Performance Report for the Public Health Directorate is produced monthly and the most recent available report is presented to Health Committee when it meets.
- 1.2 The report is presented to provide the Committee with the opportunity to comment on the financial and performance position of the services for which the Committee has responsibility.

#### 2. MAIN ISSUES

2.1 The March 2015 Finance and Performance report is attached at Appendix A. The previous report presented to Committee (the January Finance & Performance Report) identified a forecast outturn position to be on target for year-end. The latest position (as at the end of March) is unchanged. It is important to note that this is not an outturn report as, at the time of writing, there were still a significant number of accruals and recharges still to be processed before the accounts could be closed, and therefore this March report provides a forecast for the year-end position. The Outturn Report will be considered by the July Committee.

This month an underspend of £749k is reported due to a £111K 2.3 underspend in the Stop Smoking Service & Intervention, and relatively small underspends across most other budget policy lines which cumulatively total £638K. This is shown as an anticipated carry forward of the ring-fenced Public Health grant. It is proposed that this funding is transferred to an earmarked reserve for implementation of the Cambridgeshire Public Health Integration Strategy. Development of a Public Health Integration Strategy was requested by the Health Committee in January 2015. It will maximise the benefits of the transfer of Public Health to Local Authorities by embedding public health outcomes and delivery across a range of upper tier and lower tier local authority functions. The funding is non-recurrent, and will be used to pump prime evidence based transformation and integration to deliver public health outcomes, across County Council Directorates and District/City Councils. To meet Public Health Grant conditions, non-recurrent savings must be earmarked for public health functions, rather than entering the general reserve.

2.4 There are eighteen Public Health performance indicators in total and ten are shown as red and eight as green.
