Footnotes

- 1. It is difficult to accurately assess change over time for this indicator as it is known to have been highly influenced by a change in data collection and definition. The data for 2014/15 only include those whose reviews were completed in the previous year in the numerator and so data are not strictly comparable over time.
- 2. It should be noted that employment rate gaps in Cambridgeshire may be adversely affected by the county's generally higher than average employment rate in the general population see contextual indicator 1.08iv.
- 3. This indicator is partly influenced by the high levels of through-traffic on major roads through the county and many people killed or injured may not be Cambridgeshire residents.
- 4. These indicators have been locally RAG-rated and are not RAG-rated in PHOF. These measures are known to be influenced by variation in recording practice and so should be interpreted with caution.
- 5. These indicators have been RAG-rated locally and are not RAG-rated in PHOF.
- 6. Data for 2012/13 relate to NHS Cambridgeshire PCT and for 2013/14 to NHS Cambridgeshire and Peterborough CCG; the values and RAG-rating should not therefore be compared.
- 7. It should be noted that a low detection rate could indicate either low screening coverage or low levels of infection in the population RAG-rating is based on a current PHE target. Data by sex are locally RAG-rated.
