2.2 Training during 2018

A further half day training session is recommended in the first quarter of 2018 on a particular subject area of interest concerning looked after children and care leavers. Members are asked to identify further priority areas to be covered in this session.

2.3 Visits

In addition to training sessions, it is recommended that Members consider a establishing a programme of visits so that they can see first-hand the services being delivered, talk to front-line staff and service users and establish links with other Board's and organisations which work with looked after children and young people.
