#### 1.0 BACKGROUND

- 1.1 When children receive a Statement of Special Educational Needs (SEN) the Local Authority (LA) has to identify what provision is needed to meet the child's needs and then make it available. In order to access some of the specialist provision set out in statements, such as a special school or unit, children have to attend schools that are not their local catchment school. Under these circumstances, the LA will provide transport free to and from school.
- 1.2 At its meeting of 24<sup>th</sup> May Cabinet agreed a revised SEN Transport Policy which would contribute to achieving planned savings on the SEN Transport Policy over the next five years. Some concerns have been expressed in respect of the detail of the Policy and one error has been identified. This paper sets out proposed changes to the SEN Transport Policy which will provide greater clarity for families.
- 1.3 The changes will not impact on the delivery of savings or the implementation of the Policy. It must be emphasised that children entitled to receive free transport from the County Council will receive that transport. Cabinet also emphasised at their last meeting that the Policy should be implemented flexibly and with discretion in order to ensure that parents were not placed at a significant economic or social disadvantage as a result of the agreed changes. The Service Director: Strategy and Commissioning has delegated powers to vary the application of the policy to reflect the circumstances of individual families. These delegated powers will be applied as necessary.

## 2.0 Proposed Changes

- 2.1 A revised SEN Transport Policy is included at Appendix 1.
- 2.2 It is proposed to make the entitlement to transport clearer by amending paragraph 8.3 of the Policy from "Free transport may be provided to child/young person with statements of SEN if..." to "Free transport will be provided to child/young person with statements of SEN if..."
- 2.3 The requirement that parents submit written evidence of as to why they cannot provide their own transport previously at paragraph 8.4 (iii) of the Policy has been deleted. This requirement was included in the Policy in error. It was not intended that parents should be compelled to transport their children in return for funded mileage.
- 2.4 The approach to transporting children to out county special school placements has been altered at paragraph 8.10 to ensure greater clarity and consistency with transport to in county special schools. Parents will be asked to transport their children to out county placements but will not be compelled to do so.

#### 3.0 ALIGNMENT WITH PRIORITIES AND WAYS OF WORKING

#### 3.1 Supporting and protecting vulnerable people when they need it most

The proposed changes make the entitlement of families to home to school transport clearer and reinforce the fact that parents/carers in families eligible for free transport will not have to transport their children.
