1. BACKGROUND

- 1.1 On 19th December 2014 Cambridgeshire & Peterborough Clinical Commissioning Group (CPCCG) launched a nine week consultation on a future model for NHS 111 and GP Out of Hours services for Cambridgeshire and Peterborough.
- 1.2 NHS 111 is a national telephone service for members of the public to call when they need medical help fast but it is not a 999 emergency. The new 111 service is now national and has replaced NHS Direct.
- 1.3 The consultation is aimed at patients living in Cambridgeshire and Peterborough, including patients who attend GP practices in Oundle and Wansford. Wisbech patients will have their NHS 111 services and GP Out of Hours services commissioned by West Norfolk CCG with Wisbech Local Commissioning Group. Separate information about this service will be available in January 2015.

2. MAIN ISSUES

- 2.1 The consultation period will run from 19th December 2014 and will close at 5pm on 20th February 2015. Members of the health committee were circulated consultation documents via email on 19th December 2014. Further information on the public consultation meetings was forwarded to councillors via email on 31st December 2014.
- 2.2 Due to the consultation timescales the Health Committee will not be meeting again before the consultation closing date. The Health Committee is asked to consider if it wishes to provide a formal response to the public consultation and determine how to do this.
