#### 1. BACKGROUND

- 1.1 One of the roles of the Director of Public Health (DPH) is to produce an Annual Public Health Report. This is an independent report, which describes key statistics relating to the health of the local population and makes recommendations for action to improve/maintain population health. The Annual Public Health Report is distributed widely and made publically available on the NHS Cambridgeshire website. (attached as an Annex but not printed on this agenda in colour due to the cost but is available on the County Council's website by navigating from the Home page (<a href="www.cambridgeshire.gov.uk">www.cambridgeshire.gov.uk</a>) to Council and Democracy then Democracy Decision Making and then Agenda and Minutes and then using the drop down menu for Agenda minutes and reports to seek the correct meeting and then clicking on the report title on the agenda page and then clicking on the report attachment title.) The draft Health and Social Care Bill proposes an ongoing duty for the DPH in the local authority to produce an annual report on the health of the local population.
- 1.2 The increasing focus on Joint Strategic Needs Assessment (JSNA) in recent years has reduced the need for a detailed Annual Public Health Report, as there is considerable cross over between the two documents. The Annual Public Health Report 2010 does not attempt to replicate the JSNA, but presents a brief summary of some key health statistics for Cambridgeshire, key points and recommendations from the JSNA work carried out in 2010, reviews progress against the recommendations of the APHR 2009, and makes a small number of new recommendations.
