<b>Reasons for taking decision</b>	<p>The report was presented to the meeting to allow the officer to explain the proposals.</p> <p>It was noted that:</p> <ul style="list-style-type: none"> <li>• Avenue Road <ul style="list-style-type: none"> <li>○ Proposed restrictions are not to be implemented due to significant opposition to proposed 11am-2pm restrictions and additional double yellow lines.</li> <li>○ Parking bay to be marked out on north side up to #28</li> <li>○ H bar markings to be provided where driveways have none</li> </ul> </li> <li>• Christie Drive <ul style="list-style-type: none"> <li>○ Implement double yellow lines around existing pinch point</li> </ul> </li> <li>• Cowper Road <ul style="list-style-type: none"> <li>○ Implement shortened length of double yellow lines</li> </ul> </li> <li>• Dartmoor Drive Estate <ul style="list-style-type: none"> <li>○ Install additional double yellow lines at turning head in the southernmost point of the road</li> <li>○ Install additional double yellow lines past #22</li> <li>○ Install 11am-2pm restrictions as advertised</li> <li>○ Peaks Court install 11am-2pm restrictions as advertised</li> <li>○ Brecon Way install double yellow lines in Brecon Way up to Peaks Court and install 11am-2pm restrictions as advertised</li> <li>○ Exmoor Close install 11am-2pm restrictions as advertised</li> </ul> </li> <li>• Hodson's Drive <ul style="list-style-type: none"> <li>○ Install double yellow lines as advertised</li> </ul> </li> <li>• Parkway <ul style="list-style-type: none"> <li>○ Install double yellow lines as advertised</li> </ul> </li> <li>• Priory Grove <ul style="list-style-type: none"> <li>○ Install double yellow lines as advertised</li> <li>○ Install H bar markings where none exist and that are not covered by double yellow lines</li> </ul> </li> <li>• Snowdonia Way</li> </ul>
