Peterborough - Election counts have been confirmed: -

- 1. Thursday 6 May 2021 Verification only (Local's, Police and Mayoral)
- 2. Friday 7 May 2021 Local counting
- 3. Saturday 8 May 2021 Police and Mayoral counting

#### NEW COVID-19 FINANCIAL IMPLICATIONS SINCE LAST REPORTING PERIOD

- Peterborough Continued pressures for Covid-safe delivery of May elections.
- Peterborough Planning Highways and Property increased pressure for year-end receipts

### WORKFORCE CHALLENGES

- **Peterborough** Election team continues to plan and prepare for Thursday 6 May 2021, with support from Health and Safety and Public Health. Constitutional Services teams also supporting aspects of the election planning.
- **Cambridgeshire CC Post Room** considering options to merge bubbles as service has been unable to keep to demand in split shifts. Also reviewing issue of services sending large scale mailshots to the team without any forewarning.
- Extension of Virtual Meetings Regulations Both Councils continue to await confirmation from Government regarding the extension of the Virtual Meetings Regulations. Contingency arrangements will need to be considered for Cambridgeshire as the Council will not be able to access its new building until late summer. Public Health advice will also be needed for any return to physical meetings.

# COMMUNICATIONS

- PCC Child Protection and ASC team The Senior Lawyer continues to have monthly COVID meetings with the Designated Family Judge, with representatives from PCC CSC and CCC CSC, and the Senior Lawyer at CCC.
- **Peterborough Planning Highways and Property** continues to have weekly meetings with the Planning and Highways team on Tuesday and Property on Thursday. Staff level returned to normal with the lawyer who had Covid on a phased return to work for half a day

Part 2 – BUSINESS AS USUAL ACTIVITY

### **KEY SERVICE UPDATES – INTERNAL / EXTERNAL**

- **Peterborough Mayoral Services** Continuing to support the current serving Mayor and preparing for New Mayor May 2021.
- **Democratic Services** Planning for post 7 May, with preparation and risk planning for face-to-face meetings, training for new and existing members.
- Leaders Office Continuing to support the Leader and Cabinet members, with preparations in hand for new leader post 7 May 2021.
- Members Services Continued support to all members.
- FOI continue to work with services to respond to FOIs and take into account service demands.
- Peterborough Planning Highways and Property committees are proceeding as usual

# FINANCIAL ISSUES

- PCC Child Protection and ASC team/Joint Information Governance Services It has been agreed that, in light of the increased number of police requests to view CSC records for their criminal investigations and any criminal proceedings, a business case will be presented to JMT for additional support. It is anticipated that these requests will no longer be processed and actioned by the CP team but will come under the CCC side of the Information Governance team. The high number of Court cases held each week in Care cases may still result in the increased use of counsel.
- **Peterborough Planning Highways and Property** Recruiting for for a 4-day planning/property lawyer to fill vacancies.

### PERFORMANCE ACTIVITIES AND CHALLENGES

- PCC CP team On Tuesday the 9th of March, the formal launch of the President of the Family Division's Public Law Working Group report took place. The report is over 200 pages and sets out recommendations to achieve best practice in child protection cases. The President has expressed his wish that the new recommendations are implemented in all areas by July 2021, which the Designated Family Judge says will be a challenge. There will need to be specific training for the team on the new recommendations. The rollout of the new Public Law electronic Court application system is being trialled, but the implementation is currently on hold as the Designated Family Judge considers the implementation of the new reforms to be the most important issue.
- Peterborough Planning Highways and Property Teams struggling with capacity issues
- **Peterborough Contracts/Procurement Team**. High level of instructions coming into team with known additional work arising from ICT contracts which will need to be covered from April.
