### 26<sup>th</sup> February 1. Minute 517 - Property Issues - Land at Fordham 2008

It was agreed to declare land at Fordham (north and south of Landwade Road) surplus to the Council's requirements and at that time to authorise the Director of Finance, Property and Performance to agree terms for its disposal.

Previous reports had indicated that the land north of Landwade Road has been sold while negotiations were ongoing in respect of the land south of Landwade Road. The sale of the land south of Landwade Road was completed on 20<sup>th</sup> April.

#### 10<sup>th</sup> June 2. Minute 578 - Northstowe Trust Update

2008

To delegate to the Cabinet Member for Communities (Would now be the Deputy Leader and Cabinet Member for Community Engagement) in consultation with the then Deputy Chief Executive: ECS, after consultation with local members, the authority to explore and implement the best possible mechanism to ensure community involvement in the establishment of the new settlement called Northstowe, including the creation of a community trust if appropriate.

At the meeting of the Trust and Governance Group held on 23<sup>rd</sup> January 2009, reports were received on the latest position regarding the slippage in the development, the ongoing discussions between the Homes and Communities Agency (formerly English Partnerships) and Gallagher's and the work undertaken regarding the formation of the Trust. It was agreed that given the changes, further work to establish the Trust should be suspended until the situation became clearer. It was also resolved that in place of the existing Trust Shadow Board, a Community Partnership Group should be established. representing South Cambridgeshire District Council, the County Council, Horizons, the Primary Care Trust, Cambridgeshire and Peterborough Learning Trust (CPLT) and the Promoters to oversee the development of a Community Project Plan bringing together all work on governance, public realm, community and sports

Cabinet Member for Community Engagement / Executive Director: Environment Services. facilities and community development. This Community Partnership Group will report to councillors on the existing Trust and Governance Group on a regular basis.

It was also agreed that the funding set aside to establish the Trust should be retained until its future use is clarified. (The County Council holds this budget on behalf of all of the partners, each partner contributed £50k).

Action status: There have been no further developments with regard to the Northstowe Trust given that progress on the development has stalled. However an initial workshop to restart the process was held on the 23rd May. Members may also wish to note that the intention for the Northstowe Trust was the delivery of Cultural and Community Services, including Library services, and that in the interim, the County Council has determined to establish an independent trust for Libraries, Learning and Culture which may have significant overlaps in terms of scope and remit.

### 27<sup>th</sup> April 2010 3. Minute 159 - Agency Agreement for the Delivery of Highways Related Functions In Cambridge

It was agreed to delegate to the Acting Executive Director: Environment Services the powers to negotiate a new highways function agency agreement with Cambridge City Council, in consultation with the then Cabinet Member for Highways and Access.

Negotiations have been completed with Cambridge City Council and officers are now awaiting final agreement by the City.

### 11. Minute 289 Future Options for the Park and Ride Service

The Council will decide on the best model proposed then issue a formal invitation to tender. It is anticipated that Cabinet will be requested to approve the way ahead and invitation to tender in September (6th).

### 26. Minute 372. Cambridgeshire Public Sector Network (CPSN) Framework Contract Award

In agreeing a number of recommendations Cabinet authorised

- a) Confirming that CPSN contract documents be entered into, in line with Contract and Financial details as set out in Appendix One to the confidential report\_, on completion of final due diligence checks to the satisfaction of the Corporate Director: Customer Services and Transformation in consultation with the Cabinet Member for Customer Services and Transformation.
- b) Approve the reallocation of any surplus in the CPSN capital budget, as described in Section 2.4 of the confidential report to address the currently unfunded IT Resilience risks faced by the County Council, subject to final approval by the Corporate Director: Customer Services and Transformation in consultation with the Cabinet Member for Customer Services and Transformation.

#### Update

The Alcatel/formal standstill period of the procurement process finished without challenge from any of the unsuccessful bidders and debriefs were held on 4th and 5th May with all three bidders involved at the final stage of the procurement.

Officers are making positive progress to resolve a small number of clarifications with Virgin Media Business and are currently on track to sign the Framework Agreement at the end of May/start of June. Completion of this will allow the value of the surplus to be confirmed and reallocated to IT Resilience as per the Cabinet decision. Revised financial due diligence checks have taken place and support the award of the Framework Agreement and these will be presented to the Corporate Director: Customer Services and Transformation with the outcome of the clarifications for approval. The call down Contract and order for Cambridgeshire County Council will be placed under the Framework Agreement, with all indications at present suggesting there will be sufficient time to meet our migration deadline of 8th April 2012.

In addition progress has been made to engage additional customers to mitigate the risk to pricing from having a minimum 400 site count. Specifically Corporate Director: Customer Services and Transformation / Cabinet Member for Resources and Performance. Bedfordshire Fire and Rescue Service and the City Council have been involved in some evaluation activity.
