
### **Demand for SEND**




- The 2023 number of open EHCPs are above forecasted pupil numbers, +2.9% (212) above the 2022 estimates and +1.4% (106) above the revised estimates produced in 2023.
- The number of new initial requests received is increasing in comparison to the previous year (+20.5% increase). There has been a slight increase in the proportion of new initial requests received from the 11 to 15 age group, while those from the 5-10 and 16-19 age groups have seen a slight decrease.
- The numbers of new EHCPs issued has fallen compared to previous year (-13.5% decrease). There has been a slight increase in the proportion of new EHCPs issued to the under 5 and 11 to 15 age groups.
- The proportion of new EHCPs issued due to Social, Emotional & Mental Health primary need has increased significantly compared to previous years.
- Timeliness measures have been strong for the first half of the year but we have seen a recent decline due to increased demand, staffing capacity for statutory assessment caseworkers and Education Psychologist. We have also provided significantly more specialist placements with a further 600 places due to be delivered.
- The overall number of EHCP review meetings held has increased by 8.1% compared to the previous year, and the proportion of EHCP reviews being completed in timescale is increasing (70.1%).
- The number of ceased EHCPs has fallen slightly in comparison to the previous year (-3.7% decrease). The
  proportion of EHCPs ceased due to the young person not wishing to engage in education increased
  significantly compared to previous years although around 300 notification to cease have been sent in recent
  months which will mean this figure should be higher than in previous years.





- Data shows an improvement in children at SEND support and EHCPs in Key Stage 2.
- We recognise that there is still work to do in terms of improving to meet our statistical neighbours and national results.
- Programme for improvement being developed with Whole Education and SENDCo team has moved to school improvement team. Ongoing challenge to maintained schools and academies.
- Phonics has improved for children with EHCP and those at SEND Support

#### **Cambridgeshire Safety Valve Conditions**

## **SEND Transformation Progress**



- Internal processes improvements being developed around tribunals and mediation.
- Coordinated outreach provision from special schools to support mainstream colleagues working with children and young people with the highest SEND needs to be launched Jan 24.
- SEND OAP Toolkit delivered, with launch of sensory and physical section by Dec 23.
- Audit of policies and guidance underway and resource allocated to refresh/develop policies as required.
- Dates scheduled for half termly SEND SWAYs to schools and parent/carers.
- Mainstream bands completed, funding now to be attached, moderation of one secondary school and one primary to inform funding is ongoing. Special school banding to be co-produced with special schools Dec 23.
- System leadership strengths-based training in development for rollout from May 24.
- SAT CWOs undertaking Level 4 Certificate Statutory SEN Officer Duties and Responsibilities training.

## **SEND Transformation Progress**



- Programme reset and Head of SEND Transformation appointed.
- New Provision and Placement panel, with school representatives, launched Oct 23. Multiple teams drawn together to support effective information sharing and expertise, e.g. Attendance Service, Education Transport, SEND District Team, Place Planning, AP.
- Majority of EHCPs have been reviewed and placement queries resolved. We have reviewed over 500 EHCPs and are working with parents / young people to review future provision.
- Piloting a Time Limited Inclusion Grant with 12 schools, a model of investment in ordinarily available provision to support schools in meeting need without an EHCP.
- Developing a behaviour panel pilot in Huntingdon.
- Implementing improvements to the SEND front door.
- Programme of work developing capacity through ERBs, special school expansion and two new free special schools.
- New case management system (CACI Impulse Nexus) to be implemented by March 24.
- Two new free school special schools progressing with DfE input

# LGA SEND System Peer Review Findings Cambridgeshire County Council



4-day review with 5 peers from the Local Government Association took place 21st to the 24th November. Key findings -

- Recognition of a period of upheaval and reset for the local area 'Strategic intent is articulated, green shoots of implementation emerging'.
- Commitment, drive and energy to serve children with SEND and their families well is apparent at all levels.
- Well constituted SEND Executive Board committed to 'making SEND everybody's business' but further work to make sure all elements of the system are challenging each other.
- Clear lines of accountability and governance evident through HWB and ICB.
- Pinpoint has strong embedded connections with strategic partners reach is increasing but not all parents are aware.
- Safety Valve currently enables local areas to build capacity to meet need but creates future risk to achieve financial sufficiency and deliver outcome focussed change.
- The limitation of data across the system to inform strategy and direction is a risk new systems due to be in place in March will alleviate this concern.
- Further work is needed to bring the whole system together through updated local area needs assessment and a unified approach to outcomes including further focus on joint commissioning.
- Capacity is challenging to meet increasing levels of need both specialist staffing and specialist placement capacity. However, the local area is building new provision / services across the partnership to respond to challenges.
- Action plan being developed and SEF being updated to reflect feedback / areas of strength and weakness.

## **Safety Valve Agreement**



- Significant financial challenge as demand has exceeded funding increases. £50m accumulated deficit on £108m budget. Unchecked this deficit would have reached £120m by 2026/27.
- CCC signed a Safety Valve Agreement in March 2023 Revenue contribution of £49m from the DfE to support the repayment of the deficit, supported by a contribution of £9m from the Council's reserves. Two new special free schools for Cambridgeshire to be established in March (opening September 2026) and Gamlingay (opening September 2025) and a further £11.3m for capital funding to support new SEND provision on mainstream school sites.
- On track to deliver all the system reforms required by the DfE but the pressure of demand and inflation means there is a current gap in our position. Working with the DfE to address shortfall.

### Impact on Cambridgeshire's Safety Valve Model



Our September return to the DfE showed a £3.6m in-year adverse variance to the SV plan which was projected over the lifetime of the SV deal. The latest revised forecasts are showing an in-year position in excess of £6m off-track as a result of the continuing increase in demand.

As a result of these challenges, the DfE have written to the Local Authority outlining that we will be part of the Enhanced Monitoring and Support Programme with a view to submitting an updated SV plan. A meeting took place in November and it is our intention to reset our model to balance at the end of the period (26/27). A number of the original programmes have been delivered and we have developed further mitigation to resolve.

The challenges around the funding gap –

- 1. Growth and Demand as outlined in previous section
- 2. Inflation Inflation on placements is increasing on average by between 5% and 8%. The model submitted, as outlined, did not allow for this level of inflation. There will be a challenge ongoing with a 2.8% increase in funding with a pay award at a minimum of 6.5% (higher for TA roles)
- 3. Complexity Review of Tuition / AP provision has shown needs cannot be met in mainstream and specialist provision needed. There are also more permanent exclusions in primary than in previous years requiring AP provision especially from rural communities. The proportion of new EHCPs issued due to Social, Emotional & Mental Health primary need has increased significantly compared to previous years.
- 4. Delay
  - the delay in DfE delivered projects is significant. It is expected that the new special school at Gamlingay will be delayed a year and the delay in the expected opening of the new secondary school in Fenland (DfE led) is leading to requirement for more AP for unplaced.
  - We have also been unable to deliver some of the expected in year savings due to capacity within the LA. Capacity now in place.
  - Additional capacity created through new Head of SEND Statutory Duties / Head of SEND Transformation (started 1<sup>st</sup> December) and Head of Statutory Assessment (January 2024)
- 5. System / Data Reporting on the safety valve remains a challenge information produced manually. Delay in implementing new MIS system due to supplier issue delayed until mid March 2024 and unlikely to be able to report until June 2024.
