PROPOSED AMENDMENTS TO SPECIAL EDUCATIONAL NEEDS (SEN) HOME TO SCHOOL TRANSPORT POLICY

1.0 BACKGROUND

- 1.1 When children receive a Statement of Special Educational Needs (SEN) the Local Authority (LA) has to identify what provision is needed to meet the children's needs and then make it available. In order to access some of the specialist provision set out in statements, such as a special school or unit, children have to attend schools that are not their local catchment school. Under these circumstances, the LA needs to provide transport free to and from school. Historically, Cambridgeshire has had a very flexible approach to delivering this duty which has potentially been more generous towards the wider circumstances of the family than is required by law. It is also worth saying that many LAs have already reviewed their home to school policy to adopt a tighter approach to provision in order to achieve savings.
- 1.2 Over the past ten years we have seen the numbers of children receiving free home to school transport grow from approximately 900 to currently approximately 1300. This has impacted on the budget. Within the Integrated Planning budget round 2011/12 it was agreed to review the approach to providing SEN transport to make sure that the Council fulfils its statutory duty, but does so in the most efficient way possible. During the review of the SEN policy careful consideration has been given to conversations with parents and special schools. As a result we are proposing to revisit the SEN home to school transport policy in a number of areas where savings can be achieved without placing the LA at risk of failing to deliver its statutory responsibilities i.e. meeting assessed need.
- 1.3 The specific duty on the LA is to make transport arrangements if it is considered necessary, in order to get children with Special Educational Needs (SEN) and disability with a Statement of SEN to school. Whilst this assistance has to be provided free it is up to the LA to decide what is necessary and how to provide it. Case law suggests that where a child is registered at the nearest suitable school and that it is beyond walking distance then it is unreasonable not to provide transport. The SEN Code of Practice recommends that the LA has a general policy relating to transport for children with SEN and that this is made available to parents / carers.
- 1.4 Cambridgeshire County Council has a Home to School Transport Policy for mainstream and SEN transport. Two sections are dedicated to SEN and these sections detail eligibility, the expectations of parents / carers and the service the LA will provide. The majority of LA's have similar policies and apply strict eligibility criteria.
- 1.5 The majority of children and young people with SEN and/or disability and a statement do not need specialist free home to school travel. They either live within the statutory walking distance or their parents remain responsible for getting them to and from school. 1300 children / young people in Cambridgeshire do receive free home to school SEN transport. The majority of these children / young people attend special schools or specialist provision but there are a small number attending mainstream schools who have been placed by the LA in order to have particular needs met. The cost of transporting these children was £6.6 million in 2010/2011.
- 1.6 Our proposals within the Integrated Planning Process (IPP) set out savings of

the following order to be delivered by the SEN transport budget over the next five years.

2.0 PROPOSALS AND MAIN ISSUES ARISING

- 2.1 This paper sets out our proposals for achieving these savings. The savings are deliverable, but it is equally clear that whilst the proposals ensure the Council continues to deliver its statutory responsibilities, they will cause some anxiety for parents who may be upset about their eligibility for free home to school transport being withdrawn. It will be important to continue to talk to families about these changes and in particular reduce concern amongst those families that will continue to be eligible for transport.
- 2.2 The non decision making Policy Development Group (PDG) on the 20th January 2011 considered initial proposals and over the past 6 weeks officers have consulted extensively with parents / carers on proposed changes to the eligibility criteria.
- 2.3 Officers have undertaken an extensive consultation on these proposals and have written to all parents who are likely to be affected. Parental feedback has been considered in drafting an amended policy. The feedback from the consultation indicated that most parents understood the need to make changes and the broader context, but wanted to know what it meant for their child.
- 2.4 Having considered the responses from parents and carers, the following changes to the SEN Transport Policy are proposed in order to achieve the savings set out above:

When children / young people meet criteria for transport parents / carers will be asked if they can transport their children / young people to school and be offered reimbursement for fuel costs. 2.5 It should be noted that the above estimated savings, whilst based on existing data may, vary due to other influences such as changing numbers in out county schools, increase in medical needs requiring transport etc. The budget has been set up so that we are able to identify the separate areas within the proposal and to monitor the

impact of the proposed changes on actual spend A draft proposed SEN Transport policy is attached as **Appendix 1**.

2.6 Issues arising from these proposals include:

Parents, carers and schools often view transport as necessary for children with Statements of SEN irrespective of the distance a child may live from their school and their needs and therefore there is an incorrect expectation that a statement equates to transport.

- 2.7 These proposals will mean changes for some families whose children have received free transport for a number of years. Whilst the policy will need to be fairly and consistently applied, in the first year there may need to be an understanding of the implications for these families who will need to alter their childcare arrangements. This will mean the LA taking into account individual circumstances and allowing for some flexibility in year 1.
- 2.8 The practicality of walking to school may create difficulties for some families. Therefore officers from the Statutory Assessment and Resources Team (START) and the Social and Educational Transport (SETT) will work with the Travel Officer from Infrastructure and Head teachers from our special schools to develop schemes to offer support for those children and young people who will be walking to school e.g. walking buses. This will support the priority to help children live healthy and independent lives in the community and promote independent travel.
- 2.9 These proposals place responsibility for transport with parents where the eligibility criteria is not met. There will be difficulties for some parents in getting to two or more schools at the beginning or end of the school day. Additionally parental illness may lead to school absence. Officers will work with parents, other services and special schools to identify alternative strategies to support parents such as buddy schemes,. We do need to able to respond to exceptional needs and this would be through our County Resourcing Panel
- Parents have been informed of these proposals and their views sought. The
 2.10 proposals should not therefore be a surprise but some parents and children will be
 anxious about the changes, some will be upset and many will need to make
 changes to accommodate the proposed withdrawal of transport. We will work closely
 with all parents to support them and their children through this process. The Head
 of Commissioning Enhanced Services will write to parents /carers at the beginning
 of June 2011 to inform them about what the changes will mean for their child /
 young person and to provide details of the appeals process. An appeal process will
 be set up.

- Children and young people have not been directly involved with the consultation so far as any change to their provision needs to be planned for and presented in appropriate ways. Without a clear understanding that there will be changes to transport it was felt to involve them at an early stage would cause unnecessary anxiety. Children and young people will be fully involved in thinking about ways of getting to school that are safe and help them to be as independent as is possible

3.0 ALIGNMENT WITH PRIORITIES AND WAYS OF WORKING

3.1 Supporting and protecting vulnerable people when they need it most

The proposed policy would ensure that the Council continues to be able to provide transport for those children for whom it is necessary. These will be the most vulnerable children and young people in the county. There will be small number of children, young people and their families who will not continue to be eligible for free home to school transport.

3.2 Helping people lives healthy and independent lives in their communities

A benefit of implementing the walking distance criteria will be to support healthy lifestyles and to encourage the development of Independent Travel. There is clear evidence that young people who undertake Independent Travel benefit from increased confidence and self esteem enabling then to participate to a greater degree in their community. It is recognised that the changes will potentially reduce

the flexibility that some parents will have to access work and other opportunities. Actions will be taken to seek to reduce this impact.

3.3 Developing the local economy for the benefit of all

The proposal will enable the Council to continue to provide transport where necessary to enable children and young people with disabilities to attend school. Within the funding available officers will continue to develop a transport service for children and young people with SEN which is safe and meets need.

3.4 Ways of Working

These proposals will ensure that we are able to continue to provide transport when it is needed and that is of high quality. The special schools and voluntary organisations will be involved in supporting parents to understand the implications.

4.0 SIGNIFICANT IMPLICATIONS

4.1 The report above sets out details of significant implications in 1.2 and 1.4.
