This proposal is to change the Council's policy on smoking. Currently smoking is not permitted indoors in CCC buildings or work vehicles (in line with the Health Act, 2006 and associated regulations). The new policy will require all CCC's premises (indoor and outdoor) to be smoke free, and employees would not be permitted to smoke during work time or when away from CCC premises when on CCC business.

#### **Positive Impact**

There will be a positive impact on pregnant women where exposure to the harmful effects of Second Hand Smoke (SHS) exposure will be reduced.

Smoking is a known significant contributing factor to inequality. As a result of the provision of environments supportive of non-smokers and smoking cessation combined with the provision of easily accessible stop smoking services for those employees who wish to make a quit attempt, there is a potential positive impact for those most disadvantaged.

#### **Negative Impact**

The potential exists that disabled staff members or service users who are smokers may have to travel further to find suitable locations to smoke, which may be difficult if their mobility is impaired. This is recognised in the Policy with allowance for flexibility for some service users who attend older peoples', disability or mental health day services and cannot leave the CCC premises unattended. However given the evidence of smoking being a significant contributing factor to ill health, disability, and disease, and that alternatives are available (e.g. NRT), there are also potential benefits from the smoke free environment.

After careful consideration, it is not thought that any of the other protected characteristic groups or additional characteristic groups could be impacted upon negatively.
