1 Introduction

- 1.1 The committee meeting that was held on 31 January 2005 agreed that a brief summary of all the planning applications that have been determined by the Head of Strategic Planning, under delegated powers, would be provided.
- 1.2 The Scheme of Delegation set out in Part 3D of the Council's Constitution describes the extent and nature of the authority delegated to the Executive Director: Place and Economy to undertake functions on behalf of Cambridgeshire County Council. The delegations are made either by the Full Council or one of its committees. The Executive Director considered it necessary and expedient, to authorise the Head of Strategic Planning (now the Assistant Director Planning, Growth & Environment) to undertake functions on his behalf. 2. Summary of decisions

- 2.1 Six applications have been determined under delegated powers during the period between 08/03/2023 and 11/04/2023 (the date of drafting this report), details of each are set out below:
 1. App ref: CCC/22/116/FUL Erection of a glass reinforced motor control centre (MCC) kiosk to house electrical and control equipment.

Location: Soham WRC, Broad Piece, Soham, Cambridgeshire

 2. App ref: CCC/22/139/VAR Erection of one pre-school 5-bay mobile classroom including play deck and canopy for a temporary period.

Informative: This is a Section 73 planning application that seeks to retain the existing mobile classroom unit without compliance with condition 1 of planning permission F/2004/18/CC until on or before 31 August 2028.

3. App ref: CCC/23/003/VAR Section 73 planning application for a temporary mobile classroom for a temporary period.

Informative: This application seeks to retain the existing modular building for a further period until 31 August 2028 without compliance with condition 1 of planning permission H/5015/18/CC.

Location: St Annes C Of E Primary School, London Road, Godmanchester, Huntingdon, Cambridgeshire, PE29 2WW.

4. App ref: CCC/22/130/VAR Extension to Quarry for extraction of limestone, provision of new storage building, importation of inert fill, ancillary recycling of inert material and revised restoration.

Informative This is a Section 73 application to continue the above development, with merged conditions 10 (Inert Waste Limit) and condition 11 (Mineral Importation Limit) of planning permission E/3008/14/CM to extend the time period for importing mineral for processing from the current end date of 31st December 2025 to 31st December 2035 (the end date for the quarry required by Condition 3 of E/3008/14/CM) and to merge the importation limits in conditions 10 and 11 so there would be one limit on the amount of material that can be imported whether it is waste for recycling and/or disposal or mineral for processing.

App ref: CCC/22/083/FUL Construction of a private underground power cable with associated electrical and communications equipment between North Angle Solar Farm and Swaffham Prior Energy Centre; erection of electrical substation/switch gear buildings with associated temporary and permanent compound and parking at High Town Drove, and; installation of new transformer/switch gear at the Swaffham Prior Energy Centre with associated temporary compound; and temporary typical mobile CPEN Cable recycling layout.
