PART 2, ARTICLE 11, ADVISORY PROCESS

11.04 Local Strategic Partnerships (LSPs)

The Countywide LSP (Cambridgeshire Together) and the ~~five~~ **four** District area-based LSPs **[the Cambridge City and South Cambridgeshire LSP covers two districts]** are a key element in developing integrated approaches to local service delivery, and tackling the County's most challenging problems – on health, crime, education, transport, housing and the local environment. They are also the means of developing Sustainable Community Strategies to secure economic, environmental and social well-being, Countywide and in each District area.

LSPs are non-executive bodies, which bring together at local level the public, private, business, community and voluntary sectors for a local authority area.

District area-based LSPs

- An LSP Board has been established in each district **except for Cambridge and South Cambridgeshire, which have merged to become one LSP**. The size and exact membership of each Board reflects local circumstances/experience and therefore may vary.
- Each LSP Board will normally have one County Council Cabinet member appointed from the locality by the Leader of the Council; alternative arrangements may be agreed by the Leader of the Council ~~following consultation with the other Group Leaders and other members of the LSP Board~~.
- County Councillors are likely to be involved in the LSP theme-based groups and local consultative fora.
- The role of local members in relation to LSPs will be promoted through 'In Your Patch' meetings.

PART 2, ARTICLE 13 – OFFICERS

TERMINOLOGY

In this Article the use of the word "officers" means all employees and staff engaged by the Council to carry out its functions and includes those engaged under short-term, agency or other non-employed situations.

13.01 Management Structure

- (a) **General.** The Council may engage such staff (referred to as officers) as it considers necessary to carry out its functions.
- (b) **Chief Officers.** The Council will engage persons for the following posts, who will be designated Chief Officers:

TERMS OF REFERENCE FOR JOINT DEVELOPMENT CONTROL COMMITTEE FOR CAMBRIDGE FRINGES

1. Parties

Cambridge City Council
Cambridgeshire County Council]
South Cambridgeshire District Council
(‘the Councils’)

2. Status

The Joint Development Control Committee (‘the Committee’) is a joint committee formed by resolutions of the Councils pursuant to section 101(5), Local Government Act, 1972.

3. Membership

6 Members appointed by Cambridge City Council
4 Members appointed by Cambridgeshire County Council
6 Members appointed by South Cambridgeshire District Council

4. Terms of Reference

- 4.1 The Committee’s remit is to discharge the functions (‘the functions’) set out in Appendix 1, the exercise of which have been delegated to the Committee by the parties, subject to the limitation in paragraph 4.2.
- 4.2 The Committee shall discharge the functions in respect of major developments¹ and related applications falling wholly or substantially within the areas shown edged in blue on the plans forming Appendix 3 and ancillary developments relating to such Major Developments referred to it by the relevant Head of Planning of the Council issuing the consent for the Major Development in question.
- 4.3 The Committee may exercise the subsidiary powers authorised pursuant to section 111, Local Government Act 1972 in connection with the discharge of the functions.
- 4.4 The Committee may exercise the powers of delegation contained in section 101(2), Local Government Act 1972.
- 4.5 All members shall be entitled to vote on the following applications: Trumpington Meadows; Cambridge Northern Fringe East; Cambridge East; Northwest Cambridge including all of the

¹ A major development is defined by reference to Article 1 of the Town and Country Planning (General Development Procedure) Order 1995 as in force on 1 March 2010 or as subsequently amended or replaced and means development including any one or more of the following:

- (a) the mining and working of minerals;
- (b) waste development;
- (c) the provision of dwelling-houses where
 - (i) the number of dwelling-houses to be provided is 10 or more; or
 - (ii) the development is to be carried out on a site having an area of 0.5 hectares or more and it is not known whether the development falls within paragraph (c)(i);
- (d) the provision of a building or buildings where the floor space to be created by the development is 1,000 square metres or more; or
- (e) development carried out on a site having an area of 1 hectare or more.
