## 1.0 INTRODUCTION

1.1 Article 16 of the Council's Constitution requires the Council's Monitoring Officer (the Local Government Shared Services Director: Legal) to keep the Constitution under review and to recommend changes to secure improvements.

## 2.0 CHANGES TO POLITICAL MANAGEMENT ARRANGEMENTS

- 2.1 The report circulated with the Council agenda included reference to the likelihood of additional changes to the Constitution being required as a result of discussions with the new Leader of the Council and as a consequence of planned changes to Cabinet portfolios. Details of additional changes are set out in Appendix 1.
- 2.2 In summary the changes, if approved, are designed to:
  - Abolish Policy Development Groups with immediate effect.
  - Introduce Overview and Scrutiny Committees.
  - Amend the County Council procedure rules to introduce a single, time limited item for Members to ask questions of the Leader of the Council, Cabinet member, the Chairman of any Committee and/or representative on the Police and Fire Authority. This replaces the discussion on Cabinet 'information' items and Members' Oral Question Time.
  - Allow the Leader of the Council and/or Cabinet member to convene ad hoc task and finish advisory groups.
  - Change the process for securing changes to the advisory process.

For ease of reference the proposed changes to the Constitution are grouped under these broad headings.

2.3 It is proposed to introduce these changes as a matter of urgency so that the new arrangements can be introduced at the start of the new municipal year and adjusted to take account of new Cabinet portfolios and proposed working arrangements. However, the suggested changes to facilitate a move to overview and scrutiny arrangements are interim, pending more detailed work to develop new overview and scrutiny procedure rules. It is recommended that the Council authorises the Scrutiny Management Group, in consultation with the Leader of the Council and Monitoring Officer, to work up detailed operating principles to govern future overview and scrutiny arrangements.
