

Children and Young People Committee Decision Statement

1. Apologies for absence and declarations of interest

Apologies for absence were received from Councillor P Slatter, substituted by Councillor L Nethsingha; and from F Vettese, co-opted member representing the Roman Catholic Diocese of East Anglia.

There were no declarations of interest.

2. Changes to Committee Memberships

Councillor A Bradnam was appointed to the Committee on 18 May 2022, replacing Councillor M Atkins, who became a substitute member of the committee.

3. Minutes – 17 May 2022 and Action Log

The minutes of the meeting on 17 May 2022 were approved as an accurate record, subject to a typographical correction. The action log was noted.

Decisions

5. Finance Monitoring Report – Outturn 2021-22

It was resolved to review and comment on the report.

6. Finance Monitoring Report – May 2022

It was resolved to:

- a) Review and comment on the report.
- b) Note the changes to the capital programme budgets from the Business Plan as summarised in Appendix C for approval by Strategy and Resources.

7. Proposed approach for developing capacity for school placements for children with Special Education Needs and Disabilities (SEND)

It was resolved to:

- a) Approve the proposed delivery approach, aimed at meeting demand for SEND placements;
- b) Approve an amendment to the current specification for new build schools to include 55m2 of additional SEND space, per up to 2FE, as standard;
- c) Consider the feasibility study for the new area special school in Fenland at Children and Young People Committee once complete.

8. Family Safeguarding Services

It was resolved to:

- a) Agree an extension to Barnardo's grants agreement to provide Domestic Abuse Victim Support Workers for the Family Safeguarding services.
- b) Agree to enter into a Section 75 Agreement with Cambridgeshire and Peterborough Foundation Trust to deliver adult mental health practitioners for the Family Safeguarding service.
- 9. Family Hubs Feasibility Study

It was resolved to:

Approve recommendation two from the feasibility study executive summary report and proceed towards implementation over the next two years.

10. Re-commissioning of Translation and Interpretation Services

It was resolved to:

- a) Approve the re-commissioning and procurement of Translations and Interpretation Services; and
- b) Delegate responsibility for awarding a contract for the provision of Translation and Interpretation services starting on the 8th of November 2022 to the Executive Director: People and Communities, **in consultation with the chair and vice chair of the Children and Young People Committee.**

It was resolved to consider the content of the report and appendix and request a further report in 12 months.

12. Additional Public Health funding for activities supporting children and young people 2022/23

It was resolved to endorse this additional investment.
