

### Adults and Health Committee Decision Statement

Meeting: Thursday 10<sup>th</sup> October 2024 Published: Monday 14<sup>th</sup> October 2024

1. Apologies for absence and declarations of interest

Councillor C Daunton declared in Item 4: Mental Health S75 Agreement Extension as a County Council appointed partner governor at Cambridgeshire and Peterborough NHS Foundation Trust.

4. Mental Health S75 Agreement extension

It was resolved to:

a) approve the extension of the existing Mental Health Social Work Section 75 Agreement for 2 years on a 1+1 basis from 1 April 2025 at a total value of £1,250,090 per annum. This represents £2,500,180 for the total contract period and will be adjusted for future inflationary uplifts agreed as part of the established business planning process; and

b) delegate authority for awarding and executing of any subsequent extension periods to the Executive Director for Adults, Health, and Commissioning, in consultation with the Chair and Vice Chair.
