Exclusion of Press and Public	<p>It was resolved unanimously to:</p> <p>exclude the press and public from the meeting on the grounds that the following report contained exempt information under Paragraphs 1, 2, 3 and 4 of Part 1 of Schedule 12A of the Local Government Act 1972, as amended, and that it would not be in the public interest for this information to be disclosed: information relating to any individual, information which is likely to reveal the identity of an individual, information relating to the financial business or affairs of any particular person (including the authority holding that information) and information relating to any consultations or negotiations, or contemplated consultations of negotiations, in connection with any labour relations matter arising between the authority or a Minister of the Crown and employees of, or office holders under, the authority.</p>
